IT is hereby notified that the Minister of Finance, Economic Development and Investment Promotion has, in terms of section 235, as read with section 120, of the Customs and Excise Act [Chapter 23:02], made the following regulations:—

- 1. These regulations may be cited as the Customs and Excise (General) (Amendment) Regulations, 2024 (No. 122).
- 2. The Customs and Excise (General) Regulations, 2001, published in Statutory Instrument 154 of 2001, are amended in PART XIII by the insertion of a new section after section 141—

"Rebate of duty on goods for incorporation in the construction of new cities

- 141A.(1) Subject to this section, the Commissioner may grant a rebate of duty on such capital equipment and materials imported by *Approved Contractors* for the construction of new cities in line with Government development agenda, excluding motor vehicles, fuel, cement, consumables and other materials available in Zimbabwe at competitive prices and comparable quality. Other inputs such as furniture may be imported under rebate of duty provided Approved Contractors justify, to the satisfaction of the Secretary responsible for Finance, that such goods cannot be sourced in Zimbabwe at competitive prices and comparable quality. The Capital equipment and materials listed in the Schedule quality for a rebate.
- (2) For the purposes of this section, the term Approved Contractor means any Contractor approved by the Secretary responsible for Finance, for customs purposes, for the construction of new cities.
- (3) Any person wishing to be granted the rebate in terms of this section shall make an application to the Commissioner, giving details of—
 - (a) the goods referred to in subsection (1) on which a rebate is sought; and

- (b) the purpose for which the goods are to be used.
- (4) Capital Equipment or materials referred to in subsection (1) shall form a permanent part of the finished project.
- (5) If any goods referred to in subsection (1) are not used in the construction of the project concerned, the duty rebated by subsection (1) shall become payable in full.
