Traffic Safety Council (Service and Other Fees) Regulations, 2022

IT is hereby notified that the Minister of Transport and Infrastructural Development has, in terms of section 38 of the Traffic Safety Council Act [*Chapter 13:17*], made the following regulations:—

*Title*

1. These regulations may be cited as the Traffic Safety Council (Service and Other Fees) Regulations, 2022.

*Interpretation*

2. In these regulations—

“co-operating agency” means any person registered by the Council for twelve months at a time to provide the defensive driving course on its behalf.

*Fees*

3. The service and other fees prescribed by the Minister are set out in the Schedule.
